

## General terms and conditions for ordering a start license and participating in KNHS equestrian activities

- A start license with a validity of 12 months will be renewed annually, unless the license is cancelled 4 weeks before the renewal date through Mijn KNHS. A confirmation of each cancellation in Mijn KNHS will be sent by e-mail. If the license is not cancelled in time the costs for the next 12 months will be charged.
  - A day, week and month start license will automatically be signed out after the end date.
  - One start license must be applied for per combination or team (unless the relevant discipline regulations state otherwise).
  - The start license holder is responsible for ensuring that the data on the digital start license is correct.
  - An order for a start license or membership can be cancelled within 10 calendar days by sending an email to [ledenadministratie@knhs.nl](mailto:ledenadministratie@knhs.nl) provided it has not been used.
  - With a veterinarian's statement or family physician's statement, a portion of the 12-month start license can be credited in the event of injury. It is calculated how much the start license holder will receive back from the day of signing out until the end date of the start license. This request can be made by e-mail to [ledenadministratie@knhs.nl](mailto:ledenadministratie@knhs.nl).
  - Start licenses for a period day/week/month can be changed once to a date within 12 months from the start date. This request must be made within 10 calendar days from the start date via [ledenadministratie@knhs.nl](mailto:ledenadministratie@knhs.nl). The license must not have been used yet.
  - Applied for starting license can be credited in case of death of the horse. For this purpose you can e-mail a death certificate to [ledenadministratie@knhs.nl](mailto:ledenadministratie@knhs.nl). The remaining term of the starting license will be credited from the moment the KNHS has been notified that the horse has died.
  - Participants are expected to know and comply with the KNHS (competition) rules (see <https://www.knhs.nl/top-sport/meedoen-aan-wedstrijden/wedstrijdreglementen/>).
  - The start license holder agrees to the provision of reference number and name data for the purpose of the competition programmes with which the KNHS has entered into a cooperation agreement.
  - The start license holder agrees to (online) publication of names on start and/or results lists for equestrian activities.
  - By registering for equestrian activities through Mijn KNHS, the start license holder gives permission for his/her contact information to be available to the organization in question.
  - By registering for equestrian activities through Mijn KNHS, the participant also gives permission for the making of image and/or sound recordings during the activity for reporting and promotional purposes on websites, social media and offline publications. The organization has full rights to the use of the images/recordings in question. The participants cannot claim any compensation or anything in this regard.
  - The KNHS, the organization and any other person involved in the equestrian activity are not liable for damage in any form whatsoever to persons, horses and/or equipment. Participants take part and/or are present at their own risk.
